

GOBACA Waiver Form - 2007

GOBACA 2007 requires the following release for each rider, signed by the rider or (if under 18) the rider's parent or legal guardian:

ASSUMPTION OF RISK - RELEASE & WAIVER of LIABILITY

The GOBACA Ride is an organized bicycle ride through the back roads of Clinton, Highland, and Adams counties. The GOBACA Ride is presented by the Wilmington Bicycle Club. I hereby declare my desire to participate in The GOBACA Ride.

I understand and agree that riding a bicycle on the roads exposes a bicycle rider to numerous risks, including but not limited to the risk of death or serious bodily injury. All risks cannot possibly be listed. However, risks that may be encountered include potholes, debris and other road hazards, motorists, dogs, inclement and unpredictable weather and collisions with other cyclists. I fully understand the risks and completely assume all risks, known and unknown, of participating in The GOBACA Ride including the risk of death or serious bodily injury.

Recognizing the possibility of death and serious bodily injury associated with participating in The GOBACA Ride and in consideration for the Wilmington Bicycle Club accepting the rider as a participant in The GOBACA Ride, I hereby agree to waive, release, hold harmless and/or discharge the Wilmington Bicycle Club, all affiliated organizations, representatives and sponsors, and all volunteers, contractors, ride officials, agents, members, employees, and all other persons or entities associated in any way with The GOBACA Ride, from any and all claims or liabilities of any kind which are made or could be made by me, or on my behalf, as a result of the my participation in The GOBACA Ride even though such claims may arise due to the negligence, carelessness or recklessness of the persons or entities released herein.

This release and waiver of claims is binding on me, my heirs, executors, administrators, legal representatives, assigns and successors in interest. I understand that I am giving up my right to sue the persons named above and giving up other valuable and substantial rights in exchange for being permitted to participate in The GOBACA Ride.

I further agree to abide by any decision of any person associated with The GOBACA Ride relative to the event or my ability to participate in the event.

I further agree and understand that wearing an approved bicycle helmet at all times while participating on The GOBACA Ride is a requirement of participating in the event. I agree that if I choose to ride or attempt to ride in The GOBACA Ride without a helmet I am no longer an official rider or participant in The GOBACA Ride and I thereby waive any and all benefits associated with being a participant in this event.

I hereby grant to the organizers, sponsors and promoting organizations the right to photograph, videotape or otherwise capture my image, appearance or likeness and to use such images for any legitimate purposes, commercial or otherwise.

By signing this Release, or digitally acknowledging acceptance of its terms, I agree that I have read the terms, agree to be bound by the terms and do so voluntarily and knowingly. If I am registering a minor child, I hereby execute this Release on behalf of my minor child with a full and complete understanding that I am executing a release and waiver of potential claims on behalf of myself and my minor child.
